Raffle

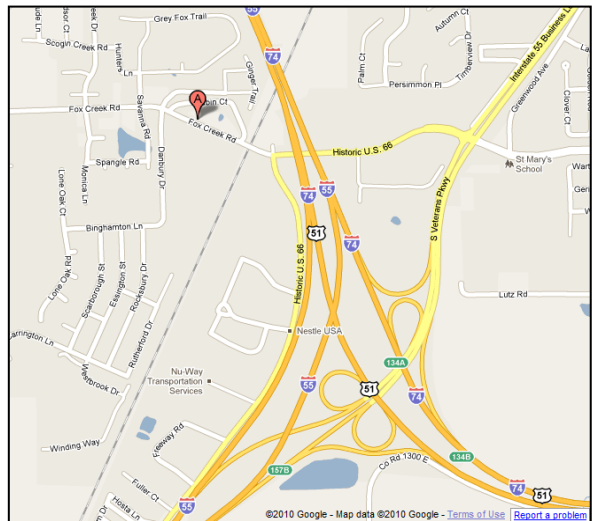
We will have a raffle on Saturday. One of the items in the raffle is a beautiful handmade quilt made by Michelle Wright.

Entry Fees:

\$20 per dog first entry, \$18.00 each additional entry SAME DOG, same day, if postmarked by 8/14/2020.

Entries postmarked after 8/14/2020, \$25 per dog per class. For Exhibition Only- \$10 per dog per class. FEO runs will not count towards a title, just for fun runs. Pre-Entries as FEO will be held until 8/14/2020 and accepted if trial has not filled by that date. Any change to entries including cancellations must be made by email to the Trial Secretary: Gail Vlahovich gail.vlahovich@gmail.com Cancellations received after 8/14/2020 will not be eligible for a refund. Entries submitted via Federal Express or Express Mail will be accepted only if the signature waiver is signed. No telephone, e-mail, or fax entries will be accepted.

If trial is not full, Day of Show entries will be accepted until 8:15 am each day. Please check with Trial Secretary to verify available openings for Day of Show entries (\$25 per dog per class).

C-WAGS Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CWAGS Scent rules and regulations including but not limited to the following rules regarding entry:

- All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- All judges and trial hosts are expected to show respect to all exhibitors.
- This trial is open to all dogs registered with C-WAGS.
- Trial Hosts may elect to accept FOR EXHIBITION ONLY entries of non- registered dogs.
- Teams may be entered in multiple levels/classes at the same trial.
- Dogs must be shown by a member of the owner's immediate family.
- Collars: The dog must wear a buckle, snap or martingale collar and/or body harness in the search area. Electronic training collars and pinch collars are not allowed on the show grounds. Head halters may be worn on show grounds, but not during the search.
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge
- Safety shall always be of fore most consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- Dogs must be on leash while on show grounds unless being shown.
