I agree that I am responsible for my safety and the safety of my dog(s), family members and guests while participating in any activity or function at TCKC. I assume all risks connected with the use of the TCKC facility and its equipment, as well as participation in any activity at TCKC.

In consideration of my being allowed to participate in the activities of TCKC, I hereby waive, release and hold harmless TCKC and each of its members, officers and Board members, event organizers, seminar speakers, and event participants from any and all liability of any nature, including injury, loss or damage to myself, my dog(s) or others resulting from my participation in any activity whether it be club sponsored or private personal training, even though such liability may arise out of negligence or carelessness on the part of TCKC, it members or other present at the time of injury or loss.
